THE CONTENT PROCESS



UMPQUA RIVER



1) PRE-PRODUCTION: PLANNING

- Sign the agreement and pay a 25% project deposit.
- Moodboard & inspiration content is reviewed.
- Brand-aligned shot list is created.
- Location preview is scheduled.
- Content day(s) are scheduled.
- Production plan & logistics are approved.



2) PRODUCTION: FILMING

Your content session(s) take place. Everything on the shot list is filmed and/or photographed according to the project scope, brand goals, and visual brand identity you approved beforehand. We bring in-house equipment, videographers, and photographers who capture your intended vision.



3) POST-PRODUCTION: EDITING

There are several rounds of revisions to create the most aligned and best version of your new video and photo assets. We send an initial draft and then continue to refine it until it reflects your expected outcome. All of the content is optimized and delivered in a gallery link that expires after one year.
